You are invited to come enjoy this spring rendezvous at the site of the Trail of Courage when the redbuds are blooming. See the Fulton County Museum, Round Barn Museum, Living History Village, and how much has been done since last time you were here! The round barn and the Polke House are repaired. **AGAIN THIS YEAR WE WILL SET UP IN LIVING HISTORY VILLAGE JUST SOUTH OF ROUND BARN. WE ARE INCLUDING CIVIL WAR – SO TIME PERIOD WILL BE PRE-1865.**

Purpose: Educate the public about frontier history, preserve history and heritage of pre-1865 era. Provide a fun and relaxing time for participants! Teaching is one of the purposes for the rendezvous.

Location: Fulton County Historical Society grounds 4 miles north of Rochester on New U.S. 31.

Amenities: straw, free firewood, low price for camping & trading, free showers beside museum, free admission to the museum and Living History Village at north end of grounds. So come on out and have some fun on the banks of the Tippecanoe River. See Indian and mountainman encampments along with militia camps, blanket traders, merchant tents, more!

**SHOOTERS - RELAX AND HAVE FUN – Muzzleloading shooting will take place only if the river has not flooded the range.**

Prizes depend on Blanket Shoot tradition. Fixed sights, round ball ammunition only. Adjustable sights will be fixed with a drop of wax by the Range Officer. "Blanket" Hawk Throws will also be held.

**VOLUNTEER PROGRAM PERSONNEL - Opportunity for You to Sing & Play!** Have you an idea for a music program or historic skit that you would like to try out? Try out your idea during the Redbud Trail and earn free camping & trading. Please let us know so we can make a schedule. This is just for fun and your pleasure, so join in and make it merry! But keep it pre-1865 style.

**RENDEZVOUS RULES** - All primitive camps must be pre-1865. All dress and items to be sold or traded must be pre-1865. Pre-1865 dress required for all participants during public hours Sat. 8 a.m. to 5 p.m. Sun. 8 a.m. to 4 p.m. All shooters must be in pre-1865 outfits and use pre-1865 style rifles and pistols.

No dogs, animals, pet spiders or insects allowed except Program and Companion dogs for Handicapped. There is a veterinarian kennel near-by where you can leave your dog. DNR no longer gives permits for wild pets at public events. **All program animals and birds must be pre-approved with all paperwork SUBMITTED 6 months prior to the festival. Birds and wild animals must be held only by the owner/presenter – do not allow other participants or public to hold them. Safety first – you are responsible.**

No alcoholic beverages will be consumed between 12 a.m. and 6p.m. in the afternoon. All beverages must be consumed from primitive containers. **No drugs or controlled substances allowed.** Minors - no consuming of alcohol. Do not bring in alcohol during public hours – this is a family oriented event.

Fire safety - please put a rope around your fire to keep children and the public out. Have shovel or fire extinguisher.

**QUIET TIME after 12 a.m./midnight so all can sleep.** Be considerate of others.

This rendezvous is a family-oriented event. Please conduct yourselves and your business in a non-offensive manner.

Modern camping is away from primitive area which will be south of the Fulton County Museum and Round Barn. No hook ups, no electric except for medical purposes at museum. Don't dig firepits in the parking field - Do camp along the edge/tree line where fire pits are ok. Please fill fire pits with dirt and sod when you leave - **DON'T PUT TRASH IN THE FIRE PITS.**

No vehicles allowed in the primitive area at any time except to load or unload **ONLY** before 9 a.m. both days and Saturday evening 6 to 8 p.m. Unload and remove vehicles immediately. **DO NOT** let vehicle block roadways while you arrange your camp or booth.

Food Purveyors: must be authentic early 1800's foods cooked over a wood fire. Must comply with Indiana Health Laws.

Limit one free load of firewood per food booth. (Bring a load from home to help- **no firewood from quarantined areas please.**)

Keep modern necessities out of sight! Please be aware that the gate opens to the public at 8 a.m. even though the event officially opens at 10 a.m. Please dress historic when you first get up and be ready for the day.

**NO** camp will be allowed to tear down or leave before 4 p.m. Sunday. Let's build a good reputation by staying for the public!

**NO – REGISTERED SEX OFFENDERS** allowed to spend the night at the festival. Background checks are being done. **THIS IS SAFETY FOR ALL PARTICIPANTS.** During festival hours they can be here!

Please be aware that the gate does not open to vehicle traffic until 5:15 p.m. Sat. & 4:15 p.m. Sun. or later to allow the public, especially older folks walking slow to get out without being run over!

**No** loaded or primed firearms outside shooting area.

**No raffles allowed.** No contests allowed without prior consent by Fulton Co. Hist. Soc. Board of Directors 60 days before event.

**No** vendor is to provide or sell **face painting** for children. Indians have objected to this.

Indiana Code Art. 35 Sect. 47 **prohibits selling edged weapons** to minors age 16 and under!

**No sling shots**, no whips, no railroad lanterns, no Medieval or sorcery items, no compound bows will be displayed or sold.

**No** inappropriate touching or making inappropriate comments. Violators will be expelled.

**No** profanity, indecencies or belligerent behavior allowed. This is a family-oriented event. Violators will be expelled.

**NO crossbows or zingers.**

GENERAL ADMISSION: Adults \$3 (age 12 & older), age 11 & under free.  
FREE ADMISSION can be earned by helping FCHS during event. Call ahead.

Liability Waiver: I waive and release the Fulton County Historical Society and its agents, representatives, committees and members from any and all claims or rights to damages for injuries or losses suffered by myself and/or members of my family, directly or indirectly while participating in all Redbud Trail Rendezvous activities. I alone am liable for loss, damage, or injury to myself and my property and damage to others and their property by me, my property, family and pets while on the property of the Fulton County Historical Society. I agree to abide by the rules of the Redbud Trail Rendezvous. I am liable for my own sales tax. I UNDERSTAND THAT BACKGROUND CHECKS ARE BEING DONE FOR REGISTERED SEX OFFENDERS AND THAT THEY ARE NOT ALLOWED TO SPEND THE NIGHT AT THE FESTIVAL.
