AGAIN THIS YEAR – REGISTRATION BOOTH WILL BE BESIDE THE ADMISSION BOOTH IN THE FIELD SOUTH OF THE EXHIBITS. EVERYONE NEEDS TO CHECK IN BEFORE YOU SET UP AND GET PROPER PAPERS, PASSES, ETC. Two passes will be Issued for use during the show. Other passes can be purchased for \$2.00 each.

Gate fee is \$3.00 per person if you do not have your pass. Trading post available.

1. Please print name and address and return one copy by May 30, with payment to reserve your space(s).

2. After May 30, all spaces not reserved will become available to those waiting. If you do not show up, you will not be guaranteed a space next year. NO REFUNDS!
3. The Power Assn. and the Historical Society takes reasonable precautions for the safety of exhibits, but will not be responsible for vandalism, theft, or destruction by other means. Security on grounds at night by local Sheriff's Reserves.
4. **Set up time starts at 9 a.m., Wednesday before show. (Primitive & Camper camping at Southend of property. THERE IS A \$10 FEE FOR PERSONAL CARTS AND MUST SHOW PROOF OF INSURANCE. \$5.00 fee for electric.**
5. **OUTSIDE VENDORS** cannot enter grounds or set up until Thursday at 9 a.m. Outside spaces are FREE 25' x 20' extra is \$1.00 per foot. SPREAD THE WORD. Hours 9-8 Fri.-Sat.

2026 SHOW DETAILS – PLEASE READ

Dear exhibitors, demonstrators and vendors:

We would like to welcome everyone to attend the Fulton County Historical Power Show the 3rd Thurs-Sat. in June this year – this year June 19-20, 2026. All Colors Welcome.

REGISTRATION: ALL EXHIBITORS AND DEMONSTRATORS: need to register at the admission gate area – which is located about half way back the field. Follow the road behind (west) the museum to get to that location with your equipment to register and unload. Someone will then show you where to park your equipment. Set-up starts on Wednesday – we do have a loading dock that can be used – once the equipment is unloaded then trailer parking is allowed at the designated area to allow for public parking closer to the exhibits. After 10 a.m. on Wednesday equipment will be unloaded and driven into the exhibit field – if you need other arrangements such as (load of garden tractors to stay on trailer) someone will assist you. We want to work with everyone to make this a successful event.

TRADING POST ON GROUNDS. HAVE THINGS TO SELL – BRING THEM AND WE WILL TRY TO SELL THEM DURING THE SHOW. CLUB GETS A SMALL PERCENTAGE OF SALE.
